RESOLUTION DECLARING A FAILURE OF BIDDING AND TO CONDUCT RE-BIDDING

WHEREAS, seven (7) bidders – Agricon Impex Co., Jozeth Trading, MCX International Enterprise, Shabat Enterprises, Biclaf Agrarian Reform Community, HLYC Trading, and S & S Enterprises, Inc. - responded to the Invitation to Bid, purchased the Bidding Documents and submitted their respective bid proposals before the cut-off on 28 October 2019 at 8:30 a.m.;

WHEREAS, during the bid opening on 28 October 2019, only S&S Enterprises passed the preliminary examination of bids subject to further bid evaluation, while all the rest failed;

WHEREAS, during bid evaluation, the BAC disqualified S&S Enterprises for failure to comply with the eligibility, technical and financial requirements;

WHEREAS, S&S Enterprises filed a Motion for Reconsideration dated 6 November 2019 which was denied by the BAC in a Resolution dated 14 November 2019;

WHEREAS, Sec. 35.1 of the Implementing Rules and Regulations states that the BAC shall declare the bidding a failure when all prospective bidders are declared ineligible;

NOW, THEREFORE, FOR AND IN CONSIDERATION OF THE FOREGOING PREMISES, this Committee resolves to:

- a. Declare a failure of bidding; and

- b. Conduct a re-bidding pursuant to Sec. 35.3 of the Implementing Rules and Regulations.
