### **REQUEST FOR QUOTATION**

The Office of the Chief Minister, Bangsamoro Autonomous Region in Muslim Mindanao (OCM-BARMM), through its Bids and Awards Committee, intends to **procure livestock for the Livelihood Program of Project-TABANG** with an Approved Budget for the Contract (ABC) in the amount of **Two Million Two Hundred Fifty Thousand Pesos (PHP 2,250,000.00)**.

The procurement will be undertaken in accordance with **Sec. 53.1. Negotiated Procurement under Two-failed Bidding** of the 2016 Implementing Rules and Regulations of Republic Act No. 9184.

As such, we are inviting qualified bidders to submit their quotation/proposal duly signed by the owner or its duly authorized representative not later than **June 30, 2021/Dhu'l-Qidah 20,1442 (Wednesday), 9:00 a.m.** Kindly fill in the RFQ form attached hereto and marked as Annex "A".

Prospective bidders who will submit a proposal with the lowest calculated and responsive bid shall be selected. A copy of your **Mayor's/Business Permit, PhilGEPS Registration No., Income/Business Tax Return, and Omnibus Sworn Statement** are also required to be submitted along with your quotation.

Open quotations may be submitted at the Office of the Chief Minister, Bangsamoro Government Center, Cotabato City.

## **TERMS OF REFERENCE**

### **Procurement of Livestock for the Livelihood Program of Project-TABANG**

#### **I. SCOPE OF SERVICE**

The supplier should be able to deliver the livestock compliance with the specifications specified in Annex "B" attached hereto.

#### **II. APPROVED BUDGET FOR THE CONTRACT**

The supplier shall bid for all items described in this Terms of Reference, which shall not exceed the Approved Budget for the Contract (ABC) in the amount of **Two Million Two Hundred Fifty Thousand Pesos (PHP 2,250,000.00)**.

#### **III. PAYMENT SCHEME**

The payment shall be done upon delivery of the items.

#### **GENERAL TERMS AND CONDITIONS:**

1. **BID VALIDITY.** Bids should be valid for thirty (30) calendar days counted from the deadline of submission of bids;
2. **PRICE ESCALATION.** All bid prices for the given scope of work in the contract as awarded shall be considered as fixed prices, and therefore not subject to price escalation during contract implementation.
3. **ALTERNATIVE BIDS.** Alternative Bids shall be rejected. For this purpose, alternative bid is an offer made by a Bidder in addition or as a substitute to its original bid which may be included as part of its original bid or submitted separately therewith for purposes of bidding.
4. **TAXES.** The total price quoted is subject to withholding tax and payable check.
5. **TERM OF PAYMENT.** Payment shall be CHARGED ACCOUNT, and pursuant to Annex D Section 4.3 of RA 9184 IRR. Cash on Delivery (COD) shall not be allowed, unless accepted during bid evaluation.
6. **RETENTION MONEY.** The obligation for the warranty shall be covered by either retention money in an amount equivalent to at least one percent (1%) of every progress payment, or a special bank guarantee equivalent to at least one percent (1%) but not to exceed five (5%) of the total contract price. The said amounts shall only be released after the lapse of the warranty period or, in the case of Expendable Supplies, after consumption thereof; Provided, however, That the supplies delivered are free from patent and latent defects and all the

conditions imposed under the contract have been fully met; (GPPB Resolution No. 30-2017 dated 30 May 2017)

9. LIQUIDATED DAMAGES. No payment shall be made until full delivery of item/s is/are completed. Delay in the delivery shall be subject to liquidated damages by way of penalty @ 1/10 of 1% of each day of delay.

10. ALTERATION OF TECHNICAL SPECIFICATIONS AND TERMS AND CONDITIONS. Altering and/or amending the technical specifications and Terms and Condition(s) may be considered non-responsive / non-compliant.
