 - Bids received in excess of the ABC shall be automatically rejected

The BAC will hold the first negotiation on February 15, 2023, 9:00 a.m. at Bangsamoro Planning and Development Authority (BPDA) Conference Hall 2, Ground Floor, BPDA Building, Bangsamoro Government Center, Cotabato City. The suppliers are requested to submit six (6) copies of its eligibility, technical and financial documents enumerated in Annex "A", which is attached hereto. Bids should be submitted in a sealed envelope.

Following the completion of the first negotiation, all prospective bidders are invited to submit its best and final offer to the BAC, through its secretariat, on or before February 17, 2023, 9:00 a.m. at the Procurement Service, Office of the Chief Minister, Bangsamoro Government Center, Cotabato City.
