In view of Two-Failed biddings, the Office of the Chief Minister, through its Bids and Awards Committee (BAC), invites supplier to participate in the negotiation for the **Procurement of Cloud Service Subscription of the BICTO**, in accordance with section 53.1 of the revised Implementing Rules and Regulation (IRR) of Republic Act No. 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
2. The Approved Budget for the Contract is **One Million Two Hundred Nine Thousand Six Hundred Pesos (PHP 1,209,600.00)** inclusive of all applicable taxes.

Bids received in excess of the ABC shall be automatically rejected

3. The BAC will hold the first negotiation on **February 15, 2023, 9:00 a.m.** at **Bangsamoro Planning and Development Authority (BPDA) Conference Hall 2, Ground Floor, BPDA Building, Bangsamoro Government Center, Cotabato City.** The suppliers are requested to submit six (6) copies of its eligibility, technical and financial documents enumerated in Annex "A", which is attached hereto. Bids should be submitted in a sealed envelope.
4. Following the completion of the first negotiation, all prospective bidders are invited to submit its best and final offer to the BAC, through its secretariat, on or before **February 17, 2023, 9:00 a.m.** at the **Procurement Service, Office of the Chief Minister, Bangsamoro Government Center, Cotabato City.**
