1. In view of Two- Failed biddings, the Office of the Chief Minister, through its Bids and Awards Committee (BAC), invites supplier to participate in the negotiation for the **Lot 1. Bids received in excess of the ABC shall be automatically rejected

The suppliers are requested to submit three (3) copies of its eligibility, technical and financial documents enumerated in Annex "A", which is attached hereto.
