In view of Two- Failed biddings, the Office of the Chief Minister, through its Bids and Awards Committee (BAC), invites supplier to participate in the negotiation for the **Supply and Delivery of Motor Vehicle (1-unit van) for the Office for Other Bangsamoro Communities**, in accordance with section 53.1 of the revised Implementing Rules and Regulation (IRR) of Republic Act No. 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
2. The Approved Budget for the Contract is **Two Million Fourteen Thousand Eight Hundred Pesos (PHP 2,014,800.00)**, inclusive all applicable taxes.

Bids received in excess of the ABC shall be automatically rejected

3. The BAC will hold the negotiation on **June 5, 2024, 9:00 a.m.** at **3rd Floor, Bangsamoro Planning and Development Authority 1, Bangsamoro Government Center, Cotabato City**. The suppliers are requested to submit three (3) copies of its eligibility, technical and financial documents enumerated in Annex "A", which is attached hereto. Bids should be submitted in a sealed envelope.

Technical Documents

- (b) Statement of the prospective bidder of all its ongoing government and private contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid; **and**
- (f) Statement of the bidder's Single Largest Completed Contract (SLCC) similar to the contract to be bid, except under conditions provided for in Sections 23.4.1.3 and 23.4.2.4 of the 2016 revised IRR of RA No. 9184, within the relevant period as provided in the Bidding Documents.

The SLCC should be Contract for motor vehicle or any other contract analogous thereto and it should be at least equivalent to the 50% of the ABC.

- (g) Original copy of Bid Security. If in the form of a Surety Bond, submit also a certification issued by the Insurance Commission;

or

Original copy of Notarized Bid Securing Declaration; **and**

- (h) Conformity with the Technical Specifications, which may include production/delivery schedule, manpower requirements, and/or after-sales/parts, if applicable (Kindly refer to the attached Annex "B" and Annex "C"); **and**
- (i) Original duly signed Omnibus Sworn Statement (OSS); **and** if applicable, Original Notarized Secretary's Certificate in case of a corporation, partnership, or cooperative; or Original Special Power of Attorney of all members of the joint venture giving full power and authority to its officer to sign the OSS and do acts to represent the Bidder.

Financial Documents

- (j) The prospective bidder's computation of Net Financial Contracting Capacity (NFCC). The NFCC should be at least equal to the ABC; **or**
A committed Line of Credit from a Universal or Commercial Bank in lieu of its NFCC computation.

- (k) If applicable, a duly signed joint venture agreement (JVA) in case the joint venture is already in existence; **or**
duly notarized statements from all the potential joint venture partners stating that they will enter into and abide by the provisions of the JVA in the instance that the bid is successful.
