Bids received in excess of the ABC shall be automatically rejected

3. The BAC will hold the negotiation on **June 5, 2024, 9:00 a.m.** at **3rd Floor, Bangsamoro Planning and Development Authority 1, Bangsamoro Government Center, Cotabato City**. The suppliers are requested to submit three (3) copies of its eligibility, technical and financial documents enumerated in Annex "A", which is attached hereto. - (i) Original duly signed Omnibus Sworn Statement (OSS); **and** if applicable, Original Notarized Secretary's Certificate in case of a corporation, partnership, or cooperative; or Original Special Power of Attorney of all members of the joint venture giving full power and authority to its officer to sign the OSS and do acts to represent the Bidder.
