Bids received in excess of the ABC shall be automatically rejected

3. The BAC will hold the first negotiation on **September 20, 2024, 9:00 a.m.** at **3rd Floor, Bangsamoro Planning and Development Authority 1, Bangsamoro Government Center, Cotabato City**. The suppliers are requested to submit three (3) copies of its eligibility, technical and financial documents enumerated in Annex "A", which is attached hereto. The SLCC should be Contract for motor vehicle or any other contract analogous thereto and it should be at least equivalent to the 50% of the ABC.

Original copy of Notarized Bid Securing Declaration; **and**

- (h) Conformity with the Technical Specifications, which may include production/delivery schedule, manpower requirements, and/or after-sales/parts, if applicable (Kindly refer to the attached Annex "B" and Annex "C"); **and**
- (i) Original duly signed Omnibus Sworn Statement (OSS); **and** if applicable, Original Notarized Secretary's Certificate in case of a corporation, partnership, or cooperative; or Original Special Power of Attorney of all members of the joint venture giving full power and authority to its officer to sign the OSS and do acts to represent the Bidder.
