SUBJECT: **SUBMISSION OF PROPOSED PROGRAMS, PROJECTS, AND ACTIVITIES TO BE FUNDED UNDER THE FY 2020 SPECIAL DEVELOPMENT FUND**

Pursuant to Section 2, Article XVI of Republic Act No. 11054 or the Bangsamoro Organic Law (BOL), the National Government shall provide a Special Development Fund (SDF) to the Bangsamoro Government for the **rebuilding, rehabilitation, and development of its conflict-affected communities.**

The amount equivalent to Fifty Billion Pesos (PhP 50,000,000,000.00), at Five Billion Pesos (PhP 5,000,000,000.00) per year, for a period of 10 years from the ratification of the said law shall be allocated to the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) for this purpose.

The utilization of the funds shall be in accordance with the Bangsamoro Development Plan (BDP) to be adopted by the Bangsamoro Government, as provided in Section 6, Article XIII of RA 11054.

With the adoption and submission of the 1st Bangsamoro Development Plan 2020-2022 by the Bangsamoro Government to the Department of Budget and Management (DBM), the **Special Allotment Release Order (SARO)** and **Notice of Cash Allocation (NCA)** in the amount of PhP 5,000,000,000 and PhP 2,500,000,000, respectively for **FY 2020 SDF allocation of BARMM**, have been released by the DBM to the Bureau of the Treasury (BTr), being the conduit in the release of funds to the BARMM Government.


Moreover, the DBM is requesting the BARMM Government to submit a **cash program containing the cash requirements/schedule for the programs, projects, and activities (PPAs) to be funded under the FY 2020 SDF allocation of the BARMM.** This will be the basis of the DBM in the release of the **NCA covering the remaining balance of PhP 2,500,000,000 FY 2020 SDF allocation of the BARMM.**

Anent this, you are hereby enjoined to submit your respective **proposed PPAs using the attached template** (see Annex 1) to the Bangsamoro Planning and Development Authority (BPDA) through email address bpda@bangsamoro.gov.ph and copy furnish to Office of the Executive Secretary email address oes@bangsamoro.gov.ph **on or before November 2, 2020.**
