1. Book IV, Title II (B), Section 18 of the Bangsamoro Administrative Code provides, thus:

"Sec. 18. Legal Liaison Network. – The Legal Officers in the Bangsamoro Attorney-General's Office and the legal officers in various Bangsamoro ministries, agencies, offices, or instrumentalities who carry out legal services or other legal duties, shall form and compose the Legal Liaison Network (LLN) of the Bangsamoro Government. They shall cooperate and coordinate on legal, policy, and legislative matters. The Bangsamoro Attorney-General shall be the *ex-officio* Chairperson of the LLN."

- 2. Considering that the Bangsamoro Parliament is scheduled to open its next regular session on January 19, 2021, there is a need to draft the Government of the Day's Legislative Agenda, for consideration of the Bangsamoro Cabinet prior to said date.
- 3. As such, all legal officers in various Bangsamoro ministries, agencies, offices, or instrumentalities composing the Legal Liaison Network (LLN) are directed to attend the1st Meeting of the LLN on January 13, 2021, 1:00 p.m., at Bajau Hall, Office of the Chief Minister, Cotabato City, to be facilitated by the Bangsamoro Attorney General's Office.
- 4. Representatives shall bring with them copies of their legislative proposals, for reference and discussions.
